Terms & Condition:

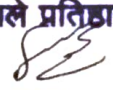
1. The society or management shall not change the medium prescribed for permission of school or location of school in future.
2. In case the management establishes school at any location other than that sanctioned by Government, the given approval shall stand null and void automatically.
3. As per the provisions of aforementioned act, the permission to establish school shall be effect from year 2018-19.
4. No classes other than permitted for Academic Year 2018-19 shall be allowed to be committed.
5. If the management doesn't establish school within 18(eighteen) months from the date permission, the given approval shall stand null and void automatically
6. It shall be binding on all schools provided with the permission to adhere to all orders and work processes issued by government from time to time as well as all provisions of the Right of children to free and Compulsory Education Act, 2009 and the Maharashtra Self-Financed Schools (Establishment and Regulation) Main Act,2013.
7. It shall be mandatory to display a sign board mentioning 'School/Class permitted on Self-Financed School Basis' at the noticeable space at the entry of school for the information of general public. The photographs captured before and after demolition of building shall be preserved along with folder.
8. The schools permitted under the Maharashtra Self-Financed Schools (Establishment and regulation) Act,2012 shall not be migrated to any other location in future.

In case of school that has obtained permission under the Maharashtra Self-Financed Schools(Establishment and Regulations) Act, 2012. It shall be required to register school in separate entry under the heading of " School/ Class having Received permission of Self-Financed Basis" while entering information in U-DISE.

10. It shall be binding on the society to implement all the prevailing present rules of Government as well as rules to be prescribed by the Government from time to time.
11. The Pre-Primary schools have not been granted permission on separate schools but have been granted permission as associated schools to the primary schools. Accordingly, permission has been granted to start standard 1st to 8th in schools to be established in this manner. It is required to fulfill 11 standards as mentioned under Sub rule (4) of the Right of Children to free and Compulsory Education Rules, 2011.
12. It is required to get the sets ascertained as per Government Resolution, dated 13th December 2013.
13. The recruitment of teachers shall be conducted as per prevailing rules and regulations. Appropriate proceedings shall be conducted while appointing TET Eligible Teachers.
14. It is required to maintain a term deposit in the joint name of society's management and Education Officer (Primary) ,Z.P., Ahmednagar in a nationalized bank for a duration of 3 Years.
